Data Disaggregations

6) Low SES (free/reduced lunch status) - a student approved for the federal government sponsored lunch program where the partial or full cost of school meals is provided by the government

Race/Ethnicity Definitions

The race and ethnicity of Iowa students was collected in a new manner beginning in 2009-2010. Iowa is making this change in accordance with federal government requirements. For school years prior to 09-10, data are presented in the previously reported race and ethnicity categories.
